THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) No 1303/2013 of the European Parliament and of the Council of 17 December 2013 laying down common provisions on the European Regional Development Fund, the European Social Fund, the Cohesion Fund, the European Agricultural Fund for Rural Development and the European Maritime and Fisheries Fund and laying down general provisions on the European Regional Development Fund, the European Social Fund, the Cohesion Fund and the European Regional Development Fund, the European Social Fund, the Cohesion Fund and the European Maritime and Fisheries Fund and repealing Council Regulation (EC) No 1083/2006¹, and in particular Article 96(10) thereof,

Whereas:

- (1) By Commission Implementing Decision C(2015) 4138, as last amended by Commission Implementing Decision C(2020) 4343, certain elements of the operational programme "Regions in Growth" for support from the European Regional Development Fund ('ERDF') under the Investment for growth and jobs goal in Bulgaria were approved.
- (2) On 22 March 2021 Bulgaria submitted, through the electronic data exchange system of the Commission, a request for an amendment to this operational programme. The request was accompanied by a revised operational programme, in which Bulgaria proposed an amendment to the elements of the operational programme referred to in points (a), (b)(i) to (v) and (d) of the first subparagraph of Article 96(2) of Regulation (EU) No 1303/2013, all subject to Implementing Decision C(2015) 4138.
- (3) The amendment to the operational programme consists mainly in allocating part of the REACT-EU resources made available to Bulgaria as external assigned revenues in accordance with Article 3(1) of Council Regulation (EU) 2020/2094² under the new thematic objective "Fostering crisis repair in the context of the COVID-19 pandemic and its social consequences and preparing a green, digital and resilient recovery of the economy" and should cover the year 2021.

- (4) Pursuant to Article 25a(1) of Regulation (EU) No 1303/2013, Bulgaria requests to apply a co-financing rate of 100% to expenditure declared in payment applications during the accounting year starting on 1 July 2020 and ending on 30 June 2021 for the new priority axis of this operational programme.
- The amendment to the operational programme consists in the addition of a new (5) priority axis 9 "Strengthening the health system for a better crisis response" with "Fostering crisis repair in the context of the COVID-19 pandemic and preparing a green, digital and resilient recovery of the economy" as investment objective. The planned actions are strengthening the capacity of the hospital network through reconstruction, design and repair activities for the establishment of isolated structures for the treatment of COVID-19 patients in 105 hospitals, providing medical and hospital equipment for 105 structures, established for treatment and care of COVID-19 patients, increasing the capacity of transfusion hematology centres for the diagnosis of COVID-19, implementing telemedicine in order to reduce the contacts of coronavirusinfected patients when receiving medical care, as well as other activities supporting investments in healthcare products and services and health and safety measures, including the provision of vaccines and medicines. In addition, specific COVID-19 related indicators are introduced, following the indicated allocation of REACT-EU resources and the previous CRII amendments.
- (6) In accordance with Article 30(1) and in accordance with the sixth subparagraph of Article 92b(9) of Regulation (EU) No 1303/2013, the request for the amendment to the operational programme is duly justified by the need to temporarily alleviate the burden on public budgets responding to the crisis situation and help secure financial support for projects as well as to quickly deploy the REACT-EU resources for crisis repair in the context of the COVID-19 pandemic and its social consequences and to prepare a green, digital and resilient recovery of the economy within the current programming period. The request for the amendment to the operational programme sets out the expected impact of the changes to the programme on fostering crisis repair in the context of the COVID-19 pandemic and its social consequences and preparing a green, digital and resilient recovery of the economy in accordance with the second subparagraph of Article 92b(8) of Regulation (EU) No 1303/2013, achieving the Union's strategy for smart, sustainable and inclusive growth and the specific objectives defined in the programme, taking account of Regulation (EU) No 1303/2013, Regulation (EU) No 1301/2013 of the European Parliament and of the Council³, as well as of the horizontal principles referred to in Articles 5, 7 and 8 of Regulation (EU) No 1303/2013.
- (7) In accordance with point (e) of Article 110(2) of Regulation (EU) No 1303/2013, the monitoring committee, at its meeting of 14 January 2021, examined and approved the proposal for the amendment to the operational programme, taking into account the text of the revised operational programme and its financing plan.
- (8) The Commission assessed the revised operational programme and did not make observations pursuant to the second sentence of the first subparagraph of Article 30(2) of Regulation (EU) No 1303/2013.

- (9) The amended elements of the revised operational programme subject to the Commission's approval under Article 96(10) of Regulation (EU) No 1303/2013 should therefore be approved.
- (10) Implementing Decision C(2015) 4138 should therefore be amended accordingly,

HAS ADOPTED THIS DECISION:

Article 1

Implementing Decision C(2015) 4138 is amended as follows:

1. in Article 1, the introductory sentence is replaced by the following:

"The following elements of the operational programme "Regions in Growth" for support from the ERDF under the Investment for growth and jobs goal in Bulgaria and benefitting from the REACT-EU resources for 2021, submitted in its final version on 9 June 2015, as last amended by the revised operational programme submitted in its final version on 22 March 2021, are hereby approved:";

2. Article 2 is replaced by the following:

"Article 2

The following priority axes shall be supported by the operational programme:

Priority axis 1 "Sustainable and integrated urban development";

Priority axis 2 "Support for energy efficiency in support centres in peripheral areas";

Priority axis 3 "Regional educational infrastructure";

Priority axis 4 "Regional health infrastructure";

Priority axis 5 "Regional social infrastructure";

Priority axis 6 "Regional tourism";

Priority axis 7 "Regional road infrastructure";

Priority axis 8 "Technical Assistance";

Priority axis 9 "Strengthening the health system for a better crisis response".";

3. in Article 4, paragraph 2 is replaced by the following:

"2. The total financial appropriation for the operational programme is set at EUR 1 377 800 138, to be financed from:

(a) the following specific budget line in accordance with the nomenclature of the General Budget of the European Union for 2014:

13 03 60: EUR 1 311 704 793 (ERDF - Less developed regions);

(b) the following REACT-EU resources made available to Bulgaria in accordance with Article 3(1) of Regulation (EU) 2020/2094 on the following specific budget line in accordance with the nomenclature of the General Budget of the European Union for 2021:

05 02 05 01: EUR 66 095 345 (ERDF REACT-EU).";

- 4. Annex I is replaced by the text set out in Annex I to this Decision;
- 5. Annex II is replaced by the text set out in Annex II to this Decision.
